Important Notes for Fund Switching

1. A Fund Switching Fee (up to 5%) will be levied by PCSec on your switching transaction, deducted directly from your securities trading account.
2. PCSec will receive a trailer commission, if any, which is a commission rebated by the securities issuers based on the net asset value under management of units in the securities arising from your subscription.

基金转换重要事項

1. 寶鉅證券將征收基金转换费 (最高为 5%)，直接从阁下的证券交易账户收取。
2. 寶鉅證券將收取由证券发行商提供的管理佣金(如适用)，根据由阁下交易并持有的证券资产总值计算。
