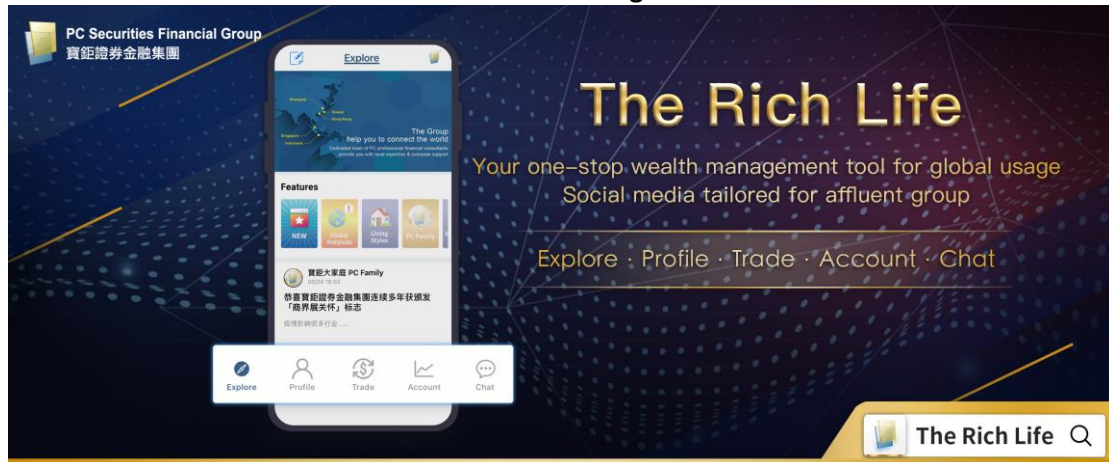


Official launch of PCSFG Wealth Management APP - The Rich Life
